- a. Personal and Community Health Division
 - i. Impact Story Laura Brown (Registered Nurse) and Kylie Davis (Health Resource Advocate) told the Board how they worked in conjunction with a local school to quickly and effectively vaccinate two families who did not speak English as their first language. They outlined how they utilized partnerships and community resources to get the families up to date so the kids could continue to go to school.
 - ii. Program Update Laura Brown (Registered Nurse) explained the waiver process to the board and the recent advancements in a state-wide update to make the process electronic.
 - iii. Program Update Luca Hicks (Health Resource Advocate) spoke to the board about a recent data collection project he was involved in with Grand Ledge Schools; ultimately the data that was collected was used to encourage the school board to hire an additional school nurse to support the students more efficiently.

b. Planning, Promotion, and Evaluation

- Program Update Maddie Vervaeke (Emergency Preparedness Coordinator) gave an update on a NACCHO grant that will improve Disease Forecasting and Analytics.
- ii. Program Update Milea Burgstahler (Planning, Promotion, and Evaluation Director) gave an overview of the OD2A grant that will work to reduce opioid-related mortality and morbidity in Barry & Eaton Counties. The Board was presented with Data in Action Reports.

- i. Impact Story Nick Justice (Environmental Health, Type II Coordinator) told the board about a recent interaction with a community member (business owner) whose water tested positive for bacteria but then had a family emergency and had to leave town. Nick was able to work with the resident and get his water retested in the timeline required by EGLE and work on solutions while the resident was out of town for his family emergency.
- ii. Program update David Comeau (Environmental Health Water Team Supervisor) gave an update on the new software the state will be using to replace WATERTRAK. This system will integrate with EGLE, State, and Federal systems to make Type II reporting more efficient and accurate.

- i. Presentation of 2024-2028 Strategic Plan Colette Scrimger (Health Officer) presented the 2024-2028 Strategic Plan to the Board.
