



## Certified Professional Food Manager Course and Testing Dates

The Barry-Eaton District Health Department (BEDHD) offers a Certified Professional Food Manager Course that meets the Michigan Food Law requirements of having a certified manager at the food service establishment. The training is five (5) hours of material to be reviewed at your own pace on your own device (computer or phone). The test will be proctored at the Health Department according to the schedule. The activation code with instructions to access the course materials will be provided at time of registration - **Due to limited testing space, payment must be received prior to receiving the course activation code.**
